Family applications should include separate forms for each child, either an AN Form where the child is now an adult (aged 18 or over) or an MN1 Form for a minor (under the age of 18). WE DO NOT NEED APPLICATIONS FOR ADULTS OR MINORS WHO ARE ALREADY BRITISH.

If you are acting as responsible adult for someone who is not of sound mind and unable to make and understand their own application (see page 10 of the Booklet AN), you must take full responsibility for the accuracy of the information provided and sign the declaration on behalf of the applicant. 
